

**SCHEDULE 3**  
**RULES AND REGULATIONS**

Last Updated: 08/01/2017

To ensure that all guests have a safe and enjoyable visit to Club Motorsports, the following rules and regulations are in effect for every event (“Event”) at our Facility. The “Facility” includes the road course, paddock, vehicle dynamics area, clubhouse, and related improvements and facilities.

1. Club Motorsports will be open seven days a week. Normal operating hours Monday through Saturday will be from 7:00 AM to 7:00 PM, with road course hours of 9:00 AM to 5:00 PM, weather and light permitting. Normal operating hours on Sunday will be from 10:00 AM to 6:00 PM, with road course hours of 11:00 AM to 5:00 PM, weather and light permitting. It will be the decision of the Facility’s operations manager or road course manager, in their sole discretion, to determine if the road course is safe for use during these hours of operation. The road course will have no lights to support driving after dark. Driving will stop once it’s determined that safe operation can no longer proceed under natural lighting conditions.
2. Before road course hours commence on Sunday, Club Motorsports will enforce a mandatory “quiet time.” At no time before 11:00 AM will vehicles be allowed to rev their engines or generate excessive noise.
3. Club Motorsports operates under strict limits on hours of operation and sound restrictions. Approved vehicles may **ONLY** be operated on the road course during the approved hours and within the limits of actual times contracted, and subject to applicable sound restrictions.
4. Race/unmuffled engines may idled for the purpose of warm-up prior to road course hours. Cars also may be driven at idle speed to False Grid prior to road course hours. However, the “revving” of engines prior to road course hours is expressly forbidden, and violators may be subject to immediate removal from the Event and/or the Facility. At no time may engine noise be in violation of Club Motorsports’ dB limits.
5. During all hours of operation, with the exception of Sunday morning, which requires mandatory “quiet time,” all vehicles must stay at or below a maximum value of 92 dBA max at 50 feet from the source. The maximum value is instantaneous from a single source or a per vehicle limit. Club Motorsports requires vehicles to use mufflers or other devices in order to meet the above stated sound requirement.
6. Sound monitoring will be conducted on-site by a member of the Club Motorsports operations or road course team using methods chosen by Club Motorsports in its sole discretion. Sound monitoring will run continuously during all road course sessions.

7. In the event of a single source sound limit infraction, Club Motorsports will enact a “two strikes” policy. For example, if a vehicle exceeds the sound maximum value limit, the vehicle will be notified and required to stop participation in the road course session, return to the pit or garage area, and make the necessary changes to the vehicle in order to comply with the sound limit. Club Motorsports will measure and test the vehicle’s sound level for compliance in the pit and/or garage area and prior to re-admittance to the road course. If the vehicle exceeds the sound limit on a second occasion during that day, the vehicle will not be allowed to operate or participate in any further road course sessions for the remainder of that day.
8. Club Motorsports may impose additional penalties, fees, or fines for violating the above sound limits or other road course operating rules, regulations, or requirements, or for violating other Club policies.
9. No vehicles of any kind are permitted on the road course without the express consent of Club Motorsports.
10. The operator of any motorized vehicle, whether registered for road use or not, driven anywhere at the Facility, must hold insurance covering that vehicle and a valid state operator’s or driver’s license.
11. Every person entering the Facility must sign Club Motorsports’ standard Release of Liability prior to entry. A parent or legal guardian must sign the Release of Liability for any person under eighteen (18) years of age. Individuals will be given a wristband upon execution of the Release of Liability, and the wristband must be worn at all times and presented to Club Motorsports’ staff upon request.
12. Every person’s physical and mental condition must be such as to allow him/her to use the road course without creating undue or unusual risk to himself/herself or any other persons. Club Motorsports may establish additional regulations regarding the medical condition for those who use the road course, and may require a letter from the individual’s physician, or a physician selected by Club Motorsports, confirming that the person is fit to use the road course or any other portion of the Facility.
13. Except as approved and authorized by Club Motorsports in writing, no person under the age of sixteen (16) shall be permitted to use the road course. No person under the age of ten (10) shall be permitted to use the karting course. Club Motorsports shall have the right, in its sole and absolute discretion, to approve and authorize use of the road course by anyone under the age requirement.
14. In the interests of the safety, CMI may from time to time establish other regulations limiting or restricting the rights of guests to use the road course or any other areas of the Facility.

15. During road course operating hours, recreational vehicles such as scooters, skating systems and bicycles will not be allowed to operate in any areas of the Facility, including but not limited to the road course or on access or paddock roads. Notwithstanding the foregoing, drivers and crew members can use recreational vehicles such as ATVs, golf carts, scooters, skating systems, and bicycles as personal paddock vehicles (“PPVs”) for transportation purposes between areas of the Facility, but not for recreational use. Operators of any motorized PPVs must display a Club Motorsports-supplied “PPV” sticker in a prominent location. PPV stickers can be purchased upon arrival at the Facility. PPV operators must use common sense and caution at all times when operating PPVs at the Facility. Guests under the age of sixteen (16) may not operate motorized PPVs. Any motorized PPVs must be properly insured. Motorized “mini-bikes” are strictly prohibited anywhere on Club Motorsports’ property.
16. Alcoholic beverages are permitted at the Facility only in areas with signage specifically permitting alcohol. However, guests may not engage in the consumption of alcohol prior to the end of all on road course activities for the day, even in posted areas. Guests are required to obtain any and all liquor licenses required in connection with the sale or consumption of alcohol at the Facility in conjunction with an Event, and must provide Club Motorsports with a copy of any such licenses prior to commencement of an Event. Guests are not permitted to consume alcohol in excess such that they cause a disturbance or pose a danger to themselves or any other person. Guests who consume alcohol are not permitted to operate any vehicle (including recreational vehicles such as scooters, skating systems, and bicycles) at the Facility until the guest can do so in a manner permitted by law. A fee of One Thousand Dollars (\$1,000.00) will be assessed and payable to Club Motorsports upon demand for each and every violation of the alcohol policy as outlined above. Club Motorsports reserves the right, in its sole discretion, to remove any intoxicated person from the Facility and/or to notify the authorities if an intoxicated person causes a disturbance or poses a danger to himself or herself or any other person.
17. Pets are allowed at the Facility only if properly leashed and supervised. Pets are not permitted in any hazardous areas at any time. Pet owners are responsible for immediately cleaning up after their pet and appropriately disposing of pet droppings. Pet owners are solely responsible for any damages caused by their pet. Club Motorsports reserves the right, in its sole discretion, to require pet owners to remove pets from the Facility if they become a nuisance or create a disturbance.
18. Weapons and fireworks are **NOT** allowed at the Facility.
19. Fluid wastes must be placed in approved Club Motorsports disposal containers located at various sites in the paddocks and NEVER on the ground.
20. Guests shall take with them all broken vehicle parts, batteries, scrap metals, tires, and all other parts and debris. Club Motorsports will invoice any violator Five Hundred Dollars (\$500) for any such item left at the Facility.

21. Persons under eighteen (18) years of age who are not drivers are not permitted in the hot pits or at corner stations.
22. No passengers, other than designated instructors, are permitted in vehicles without the express consent of Club Motorsports.
23. On all access roads, driveways, pit lanes, and paddock areas, all drivers must maintain a speed limit set by Club Motorsports in its absolute and sole discretion.
  - a. Traffic on all Access Roads is limited to 20 MPH.
  - b. Traffic in All Paddocks is directional one way and limited to 10 MPH.
  - c. Traffic in Pit Lane is one way and limited to 40 MPH.
24. All cars must pass a safety inspection. Inspections are valid for sixty (60) days after issue. Any reputable dealership or an independent, certified mechanic can do the inspection. A technical inspection form will be provided prior to road course use. It must be filled out and turned in before automobiles or motorcycles can be driven on the road course.
25. Properly working restraints must be worn by both driver and passengers. Club Motorsports reserves the right to require additional protective gear and decline road course access to any individual for any reason.
26. Helmets, long sleeves, long pants and shoes are required of drivers, instructors and passengers while on the road course with the exception of parade laps.
27. Open cars must be equipped with a roll bar meeting the following specifications: (i) the roll bar must be of sufficient height to ensure that the top of the driver's helmet sits below the line from the top of the roll bar to the top of the windshield (commonly referred to as the "broomstick test"); and (ii) the roll bar must be fixed and visible at all times when the vehicle is on the road course.
28. For their safety, children must be kept under adult supervision at all times.
29. To facilitate emergency vehicle access, race and personal vehicles must not be parked on any paddock road or in any safety access lane during an Event. Any vehicle not in compliance will be towed at the owner's expense.
30. No vehicles, equipment, trucks or trailers may be brought in or left at the Facility without Club Motorsports' prior approval. An additional agreement which holds Club Motorsports harmless must be signed for each individual circumstance. Trailer drops on the day prior to an Event may be provided as a courtesy at Club Motorsports' discretion. ***NCR PCA participants will have the option to leave their trailer on the property the evening prior to the event as long as it is before 7pm.***
31. Guests desiring an electrical hookup must not have cords cross or impede any roadway or access area where vehicles or pedestrians cross, unless cords are covered

with town and state approved safety cover (e.g. “yellow jacket”, “speed bump”).

32. Camping is permitted at the Facility with Club Motorsports’ prior written consent. Campers will be charged according to Club Motorsports’ camping rate schedule. Camping will be allowed during private Events only if guests arrange for overnight security to be provided by Club Motorsports at an additional fee. The amount of security needed for overnight camping will be determined by Club Motorsports in its sole discretion. Camping in any of Club Motorsports’ buildings is forbidden. Overnight campers are prohibited from entering the road course after hours.
33. Depending on the nature of an Event, guests may be required to procure additional security, safety, ambulance, fire, or other emergency personnel at an additional fee. The amount of emergency personnel needed will be determined by Club Motorsports in its sole discretion. Guests will comply with all instructions given by such personnel and will not interfere in any way with such personnel.
34. Although grilling is permitted in designated areas, open fires are not allowed anywhere on the grounds.
35. Loud music is not permitted at the Facility.
36. Smoking is expressly forbidden at the Facility except in designated smoking areas.
37. Standing on the pit wall or applying tape to the pit wall without permission is prohibited.
38. Guests are prohibited from climbing fences and from entering areas behind spectator fences without permission from Club Motorsports’ security personnel.
39. Guests are prohibited from pounding stakes or making any holes in any asphalt surface, and from painting any asphalt surface.
40. There is limited electrical power available. A power use fee will apply to any guest wishing to use electrical power. Club Motorsports is not responsible for any failed electric service due to guest abuse or over usage, and guests will be fully responsible for any damages they cause to the electrical power supply.
41. Guests must comply with all instructional signage at the Facility and the oral directions of Club Motorsports’ employees, agents, and contractors.
42. Club Motorsports will have full access to all areas of the Facility at all times.
43. Club Motorsports reserves the right to inspect all personal property, equipment, and vehicles brought to the Facility.

44. Club Motorsports has a zero tolerance policy for illegal activities. Any suspected illegal activity will be immediately reported to the proper authorities.

45. GUESTS WHO VIOLATE ANY OF THE RULES LISTED HEREIN WILL BE RESPONSIBLE FOR ALL RESULTING DAMAGES, MAY BE SUBJECT TO ADDITIONAL FEES OR FINES, WILL NOT BE ENTITLED TO ANY REFUNDS, AND MAY BE EJECTED FROM THE FACILITY BY CLUB MOTORSPORTS, IN ITS SOLE AND ABSOLUTE DISCRETION.
